
1 In the September 23, 2019 Minute Entry, the Court requested that ADWR facilitate  
2 a meeting between the claimants and objectors in this case by October 15, 2019. ADWR  
3 held an initial meeting on October 2, 2019, at which time the parties asked ADWR to  
4 schedule a second meeting within 120 days so that the claimants could gather additional  
5 information in support of their claims. ADWR scheduled the second meeting for  
6 February 11, 2020. On January 28, 2020, Ms. Jan Rogers notified ADWR that there is  
7 some disagreement amongst family members about how to proceed and that they are not  
8 ready for a second meeting. Ms. Rogers asked for additional time to sort out issues and  
9 gather documentation in support of their claims. Ms. Rogers suggested that she could call  
10 ADWR when her family is ready to proceed. ADWR hereby notifies the Court and the  
11 parties that at the Claimants' request, ADWR is cancelling the February 11, 2020 meeting.


