DESCRIPTIVE SUMMARY: The Arizona Department of Water Resources (“ADWR”) hereby requests an extension of time until March 19, 2021 to file its Amended Watershed File Reports for the above case.

DATE OF FILING: December 17, 2020

1 In the Minute Entry Order filed October 31, 2019, the Court requested that ADWR
2 file Amended Watershed File Reports in the above case by November 2, 2020. By Order
3 dated November 23, 2020, the Court granted ADWR an extension of time until December
4 18, 2020 to file the reports.

5 ADWR hereby requests an additional extension of time until March 19, 2021 to file
6 its reports. Some of the land ownership has changed within the watershed file reports, and
7 some of the statements of claimant (SOCs) have been partially assigned to other parties;
8 this has necessitated additional investigation by ADWR. One of the partial assignments
9 was made to the United States Bureau of Reclamation. Counsel for the Bureau of
10 Reclamation has indicated that they plan to file an amended SOC by January 2021.
11 ADWR requests an extension of time until March 19, 2021 to allow for investigation of
12 those amendments so that the claims and water uses may be included in these reports.


