**DESCRIPTIVE SUMMARY:** The Arizona Department of Water Resources hereby requests an extension of time until April 4, 2022 to file its Response to Salt River Project's proposal for analyzing a potential domestic *de minimis* designation in the Verde River watershed.

1 In the Minute Entry Order filed March 10, 2022, the Court requested that the  
2 Arizona Department of Water Resources (“ADWR”) file a Response to Salt River  
3 Project’s (SRP’s) proposal for analyzing potential *de minimis* domestic water uses in the  
4 Verde River watershed by March 28, 2022. Although SRP filed its proposal as ordered  
5 on March 14, 2022, ADWR didn’t receive a copy of the proposal until March 15. Also,  
6 SRP’s proposal contains several specific actions that SRP wants ADWR to take with  
7 respect to ADWR’s analysis, and ADWR requires additional time to consider and respond  
8 to those proposed actions. ADWR hereby requests an extension of time until April 4, 2022  
9 to file its Response.
